



Jayanthi Charitable Foundation:

The Jayanthi Charitable Foundation was established in 1998 by Jay V. Subbarao, M.D., M.S. in memory of his father and brother who were a major source of inspiration and support to his professional career.

OBJECTIVES OF THE GRANT:

1. To promote the specialty of Physical Medicine and Rehabilitation (PM&R).
2. To encourage and support dedication of professionals to the care of individuals with disabilities.
3. To sponsor visiting professor lectures in the PM&R subspecialty areas of spinal cord impairment (SCI) and traumatic brain injury (TBI).

Each year two grants (one for SCI and one for TBI) in the amount of up to \$750 each will be awarded to a residency training program or educational institution or an organization.

GRANT REQUEST PROCEDURE:

1. Residency Program Director or institutional or organizational leader should submit written request to the Foundation
2. Request should describe:
 - Type of educational activity
 - Target audience
 - Estimated number of participants
 - Availability of CME
 - Designated subspecialty area (SCI or TBI) and topics to be covered
 - Name of the faculty selected
3. Grants are considered on an academic calendar year (July 1 to June 30)
4. Request should be submitted at least four months prior to the date of scheduled lecture
5. Program sponsor is responsible for coordinating the faculty travel and schedule
6. The sponsors of the lecture may supplement additional amounts without foundation permission
7. The grant recipient must have IRS tax exempt status
8. Original receipts of all expenses above \$25 must be submitted for reimbursement

Nationally recognized clinicians, educators, and researchers who are experts in SCI and TBI have been selected to participate in the JCF Visiting Professor Speakers Bureau. For grant acceptance, **visiting lecturer must be** a participant in the Speakers Bureau. Activities that benefit a larger number of members with interdisciplinary participation are preferred. Awarding of grants will be sole responsibility of the Foundation, and its decision are final.

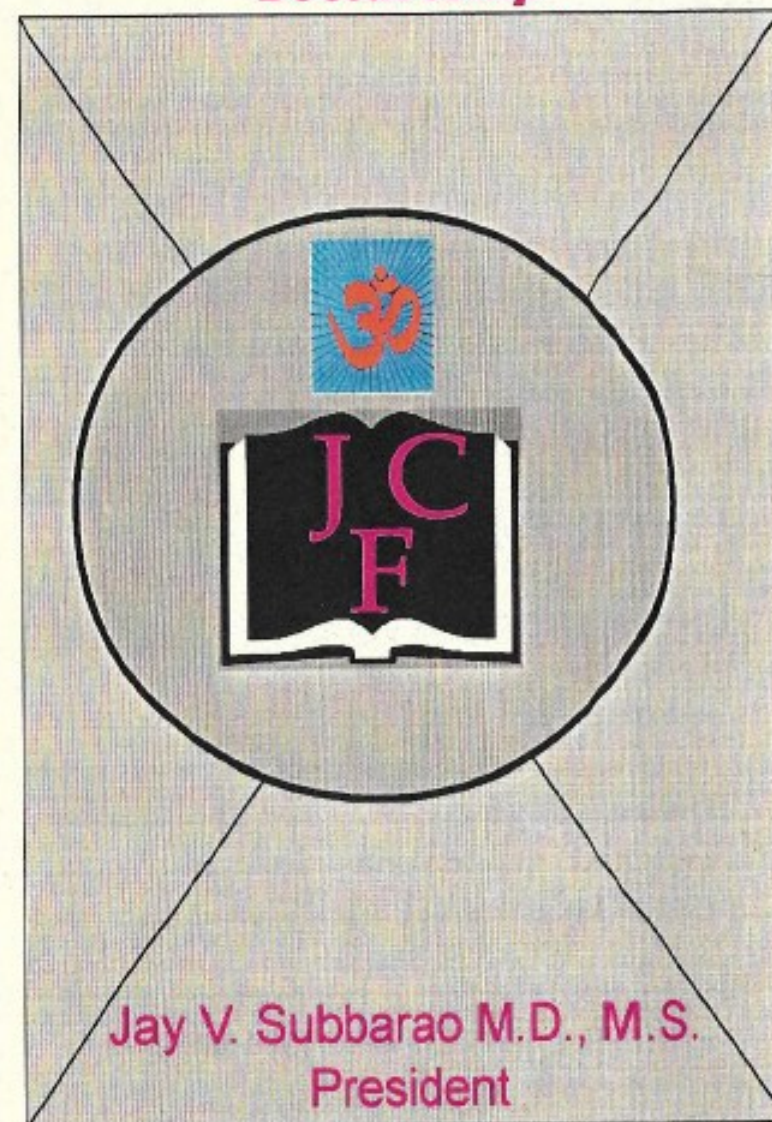
